The regularly scheduled meeting of the Atlantic Beach Town Council was held Monday, March 27, 2017 at 6:00 p.m. in the Council Meeting Room, 125 West Fort Macon Road, Atlantic Beach, North Carolina.

**CALL TO ORDER and PLEDGE OF ALLEGIANCE**

Mayor Cooper called the meeting to order at 6:00 p.m. Mayor Pro Tem Navey led the assembly in the Pledge of Allegiance.

Mayor Pro Tem Danny Navey made a motion *to excuse* Ann Batt and John Rivers from the meeting due to medical reasons. Seconded by Councilmember Archer. Vote was unanimous, 3-0. Motion carried.

**6. RESOLUTION 17-03-01: Resolution Supporting Seasonal Population Adjustment Factor for Sales Tax and Other State Revenue Distribution**

Councilmember Archer made a motion *to approve* Resolution 17-03-01: Resolution Supporting Supporting Seasonal Population Adjustment Factor for Sales Tax and Other State Revenue Distribution. Seconded by Councilmember Briley. Vote was unanimous, 3-0. Motion carried.

**7. RESOLUTION 17-03-02: Resolution Renaming a Certain Street in the Town of Atlantic Beach from “Second Street” To “North Shore II Drive”**

Staff requests the renaming of Town Street “Second Street” to “North Shore II Drive”. This street has been known and identified as North Shore II Drive since the mid-1970s and has proper street signage reflecting North Shore II Drive. Property owners, the local postmaster, NC Department of Transportation, and all affected government agencies including, but not limited to, local EMS and Police, Carteret County GIS Department, Carteret County Board of Elections and Carteret County EMS consider this street name to be North Shore II Drive.

Surveyor Jamie Phillips has been instructed to change the name from Second Street to North Shore II Drive on the Powell Bill Map. Staff has reviewed records and determined Town Council never officially renamed the street from Second Street to North Shore II Drive.

Councilmember Briley made a motion *to approve* the Resolution 17-03-02: Resolution Renaming a Certain Street in the Town of Atlantic Beach from "Second Street" To "North Shore II Drive. Seconded by Councilmember Archer. Vote was unanimous, 3-0. Motion carried.

There being no further action taken or business before Council the meeting stood adjourned. The time was 6:28 p.m.


