

# Minutes Town of Atlantic Beach, North Carolina Town Council Special Meeting Thursday, August 10, 2017



A Special Meeting of the Atlantic Beach Town Council was held Thursday, August 10, 2017 at 10:00 a.m. in the Council Meeting Room, 125 West Fort Macon Road,, Atlantic Beach, NC.

Mayor Cooper called the meeting to order at 4:00 p.m.

Mayor Pro Tem Navey made a motion *to excuse* Councilmember Archer from the meeting due to a medical appointment. Seconded by Councilmember Batt. Vote was unanimous, 4-0. Motion carried.

## PUBLIC HEARING APPROVAL TO SUBMIT GRANT APPLICATION TO DIVISION OF COASTAL MANAGEMENT FOR FUNDING FOR IMPROVEMENTS AT TOM DOE MEMORIAL BEACH ACCESS FOR A PROJECT IN THE AMOUNT OF \$56,500

Michelle Shreve, Planner, reviewed the desire to improve the Tom Doe Memorial Beach Access by constructing a structural walkway for pedestrian use. The projected costs are \$56,500 and the grant proposal requests a 50% match. Like the project recently completed at the Raleigh Avenue Public Beach Access, the addition of a pedestrian walkway over the dunes will reduce unsafe conditions of pedestrians and vehicles sharing the same unimproved pathway, as well as make this access ADA-accessible.

On March 22, 2017, staff submitted a Pre-Application and on May 25, 2017, received the Invitation to Submit a Final Application for Consideration in the 2017-18 grant cycle. Prior to submitting the final application, the local government is required to hold a public hearing to discuss the proposal. In order to meet the August 14, 2017 application submittal deadline, this special meeting and public hearing was called.

Councilmember Briley made a motion *to enter* public hearing on the proposed submittal of final application for funding for improvements at the Tom Doe Memorial Beach Access. Seconded by Councilmember Rivers. Vote was unanimous, 4-0. Motion carried. The time was 4:03 p.m.
