b) AB Causeway Corridor Masterplan

The Town is working with Alta Planning & Design to create a Causeway Corridor Master Plan in order to provide guidance for improvements to the Causeway. The Town seeks to make better use of the 200ft right-of-way and aims to maintain or increase the number of parking spaces for businesses; eliminate unnecessary curb cuts; improve bike/pedestrian/golf cart flow along and across the Causeway; improve landscaping and visibility for businesses through wayfinding.

Mayor Cooper announced the members selected to serve on the Steering Committee: Councilmember Harry Archer; Councilmember Austin Waters (Memories Beach Club); S&J Holdings; Matt Lamb (Chasin' Tales); MJ Marsh (Marsh's Surf Shop); Charles Hale (AB Realty); Fred Bunn (Causeway Shopping Center)

Councilmember Navey made a motion *to approve* the members of the Causeway Corridor Steering Committee. Seconded by Mayor Pro Tem Porter. Vote was unanimous, 5-0. Motion carried.

9. TOWN MANAGER REPORT

a) Review of Capital Projects

Circle parking additions around the water tank on East Bogue Blvd. and East Terminal Blvd.: We received bids on March 20, 2019 and Thomas Simpson Construction was the lowest bidder at \$67,640. He is ready to begin work as soon as the new fence installation is complete. We anticipate completion of the project prior to Memorial Day.

DoubleTree by Hilton beach access at the west end: We received bids on March 20, 2019 and Bogue Banks was the low bidder at \$91,800. We will have Town staff do as much of the work as possible by installing decking boards, etc. The Doubletree still intends to honor their contribution. The total amount of the local match and CAMA grant funds is \$95,705.
