CALL TO ORDER

Neil Chamblee called the meeting to order at 6:00pm.

APPROVAL OF MAY 7, 2019 MINUTES

Ramsey made a motion to approve the May 7, 2019 Minutes. Seconded by McCullough. Vote was unanimous, 6-0. Motion carried.

REVIEW OF MAJOR SITE PLAN FOR WINDFARE (Channel Bay) Staff Presentation

This major site plan proposes redevelopment of the former Channel Bay Mobile Home Park. The nine duplexes proposed for this development will be contained on one parcel, with condominium-style ownership of each dwelling unit. There will be individual electrical, plumbing, septic service and driveways for each dwelling unit. There will be open spaces and a private street provided within the common area of the development. Michelle reviewed the requirements and noted this Phase II Plan provides the necessary details required. The Technical Review Committee determined due to the location and layout of the project, it was not going to require installation of sidewalks.

Planning Board Discussion

Contractor Sammy Ballou and Engineer Ron Cullipher were present to address questions from the board. The total height of the buildings to the roofline with proposed grade is less than 45 feet, as required. Each unit is required to have two parking spaces, but could easily accommodate four or more. Each unit will have a septic system. They will start construction as soon as possible, then build additional units on demand. The streets will remain private.

Planning Board Recommendation

It was the consensus the proposed Major Site Plan for Windfare Condominiums is generally consistent with applicable UDO requirements. Batt made a motion *to recommend* the proposed Major Site Plan to Town Council for approval. Seconded by Dean. Vote was unanimous, 6-0. Motion carried.

OTHER BUSINESS

Ann Batt announced this would be her last meeting, she is resigning from the board and moving back to Kinston.

ADJOURNMENT

There being no further business Chairman Chamblee adjourned the meeting. The time was 6:27 pm.
