Mayor Cooper called the meeting to order at 6:00 p.m. and Councilmember Navey led the assembly in the Pledge of Allegiance.

Councilmember Navey made a motion to excuse Mayor Pro Tem Porter due to family commitments. Seconded by Councilmember Waters. Vote was unanimous, 4-0. Motion carried.

At the June 4 Planning Board, Ann Batt resigned due to moving full time in Kinston. It was the consensus of Council to leave this seat vacant until the next meeting allowing time to solicit potential applicants. Councilmember Archer spoke with Norm Livengood and he wishes to continue to serve. He suggested removing David Cox from the board due to declining health and lack of attendance.

Councilmember Navey made a motion to re-appoint Norm Livengood to the Board of Adjustment (term expiring 6/30/22) and to appoint Michael Bosse as a regular member (term expiring 6/30/22) and to appoint Harrison Smith to the alternate seat that was held by Michael Bosse (term expiring 6/30/22). Seconded by Councilmember Waters. Vote was unanimous, 4-0. Motion carried.

After acknowledging and thanking John Kurek and Ann Batt for their years of dedicated service, Mayor Cooper read the resolutions of appreciation aloud.

Councilmember Archer made a motion to approve Resolution 19-06-03: Resolution of Appreciation to John Kurek for service on Board of Adjustment. Seconded by Councilmember Johnson. Vote was unanimous, 4-0. Motion carried.

Councilmember Archer made a motion *to approve* Resolution 19-06-04: Resolution of Appreciation to Ann Batt for service on Planning Board. Seconded by Councilmember Waters. Vote was unanimous, 4-0. Motion carried.

### 7. PLANNING AND ZONING

# a) Review of and Call for Public Hearing for July 22, 2019 at 6:00pm on proposed Chapter 18, UDO Amendment on Backfilling Bulkheads

During the May 20 discussion of the Land Disturbance Permit ordinance amendment, concern was raised for projects involving backfilling for bulkheads. Council moved forward with adopting the amendment as presented and directed staff to generate an amendment to include backfilling bulkheads. The proposed amendment applies to bulkhead projects disturbing an area in excess of 100sf and allows for an increase of 6 inches above the adjacent grade only for the first 5 feet landward of the bulkhead. Most bulkhead projects are below 100sf of disturbed land and will not need a land disturbance permit.

Councilmember Navey made a motion *to schedule* the Public Hearing on July 22, 2019 at 6:00pm on proposed amendment to Chapter 18, UDO Backfilling Bulkheads. Seconded by Councilmember Archer. Vote was unanimous, 4-0. Motion carried.

### b) Approval of Major Site Plan for Windfare Condominiums

Michelle reviewed the project noting several permits are state issued and enforced. The Technical Review Committee determined due to the location and layout of the project, it was not going to require installation of sidewalks.

Councilmember Johnson requested further details on the drainage, landscaping and septic. Cullipher noted the drainage is designed like a big turtle shell, water will run north and east and tie into the existing Old Causeway drainage system. The UDO does not require specific landscaping, but Mr. Barbour confirmed the project will be landscaped similar to The Pinnacle. This project will cause less septic strain than the 35 mobile homes previously on the property.

Councilmember Navey made a motion to approve the Major Site Plan for Windfare Condominiums. Seconded by Councilmember Archer. Vote was unanimous, 4-0. Motion carried.

# a) Ordinance 19-06-01: FY19-20 Annual Operating Budget Ordinance

Councilmember Archer made a motion to approve Ordinance 19-06-01: FY19-20 Annual Operating Budget Ordinance. Seconded by Councilmember Waters. Vote was unanimous, 4-0. Motion carried.

Mr. Walker then provided a status update on pending capital projects: The parking expansion project around the Circle water tower was paved today, it adds an additional 40 spaces to the paid parking program. The Raleigh Ave. storm drainage project should be installed in next 10 days. The DoubleTree west end beach access pilings have been set by the contractor and town staff will begin laying decking boards.
