Councilmember Archer made a motion *to appoint* Sharron Wilson to the Planning Board. Seconded by Mayor Pro Tem Johnson. Vote was unanimous, 5-0. Motion carried. She is filling the vacancy left by Lynne Brown for a term expiring December 31, 2020.

## 12. APPOINTMENT OF BOARD OF ADJUSTMENT MEMBERS

Councilmember Waters made a motion to appoint Harrison Smith as a regular member of the Board of Adjustment. Seconded by Councilmember Archer. Vote was unanimous, 5-0. Motion carried. Harrison currently serves as an Alternate. His term will expire June 30, 2020.
