CALL TO ORDER

Mayor Cooper called the meeting to order at 2:00 p.m.

APPROVAL OF AGENDA

Councilman Archer made a motion *to approve* the agenda. Seconded by Councilman Waters. Approved unanimously, 4-0. Motion carried.

Councilman Navey made a motion *to excuse* Councilman Forrest due to a court hearing. Seconded by Mayor Pro Tem Johnson. Approved unanimously, 4-0. Motion carried.

FY21-22 DRAFT BUDGET STATUS SUMMARY

The draft budget has been made available to the public online and at town hall in preparation for the May 24 public hearing. There is a 3% rate increase in health insurance cost this year.

Mayor Pro Tem Johnson wanted to share with the board discussions he had with Mr. Walker regarding salaries. Salary dollars are actually going up 8% (\$231,000). The reason for the increase is volatility with police and fire and filling the vacancies, re-training and schooling in order to stay competitive with other towns.

Mayor Pro Tem Johnson also discussed the beach nourishment fund and using \$100,000 for dredging and beach accesses. He inquired about the boat tax funds, which are still being collected and used for marine patrol, etc.

REVIEW OF PROPOSED AMENDMENTS TO THE NOISE ORDINANCE

Chief Harvey wants to update the noise ordinance and designate a time for amplified music to end, he is proposing 10:00pm during the week and 11:00pm on weekends. Officers need a designated time so the ordinance can be enforced.

Mayor Pro Tem Johnson would like to see the entire ordinance rewritten to update the wording, it is embarrassing.

There was discussion on how to enforce loud music on the beach and the time limits for amplified music ending at night, the consensus was that 10:00pm during the week and 11:00pm at night is reasonable.

Mayor Cooper will make a few notes and send his suggestions to the Chief. Chief Harvey was instructed to send to the town attorney for review also.
