#### CALL TO ORDER

## **ELECTION OF PLANNING BOARD CHAIRMAN**

A motion was made by Ramsey *to elect* Chamblee as Planning Board Chairman for 2022. Seconded by Baker. The vote was unanimous 6-0. Motion carried.

#### **ELECTION OF PLANNING BOARD VICE-CHAIRMAN**

A motion was made by Baker *to elect* Winbourne as Planning Board Vice Chairman for 2022. Seconded by Ramsey. The vote was unanimous 6-0. Motion carried.

#### MINUTE APPROVAL

Motion to approve November 22, 2021, Planning Board Minutes was made by Ramsey. Seconded by Wilson. The vote was unanimous, 6-0. Motion Carried.

## ZTA-22-1: NON-RESIDENT MEMBERSHIP ON PLANNING BOARD

Michelle Eitner, Director presented a PowerPoint explaining ZTA-22-1 which proposes to allow one of the seven Planning Board members to be a real property owner that's not a full-time resident. This initiative was proposed by Mayor Trace Cooper following comments from the Town Council regarding the residency requirement of Planning Board members. Currently, Section 18.2.2.F.2.a requires that the seven Planning Board members must reside inside the town limits, and doesn't specify whether this is full-time or part-time residency. The proposed amendment provides that one of the seven members may be a real property owner inside Town limits that is not a resident. By using the word "may", we allow for all seven members to be residents or to have six resident members and one property owner that claims residency elsewhere.
