The regularly scheduled meeting of the Atlantic Beach Planning Board was held Tuesday, April 5, 2022 after release of Council from a Joint Council and Planning Board meeting in the Boardroom, 125 West Fort Macon Road, Atlantic Beach, North Carolina.

Prior to the Joint meeting Katrina, Town Clerk, administered oaths of office to Phillip Hursey, David Johnson and Phil Jones. During the Joint meeting Ramsey made a motion to excuse Neil Chamblee due to a medial appointment. Seconded by Wilson. Vote was unanimous, 6-0. Motion carried. Council was released during a recess at 7:04pm. Mayor Cooper stayed in the audience, all Councilmembers left the room. Planning Board resumed at 7:08pm

APPROVAL OF JANUARY 4, 2022 PLANNING BOARD MINUTES

Johnson made a motion to approve the January 4, 2022 Planning Board minutes. Seconded by Wilson. Vote was unanimous, 6-0. Motion carried.

MSP-21-1 SHOWBOAT REDEVELOPMENT

Staff Presentation

Michelle reviewed the major site plan development proposal to build eight duplexes at the former Showboat Motel site (614/702/710 Atlantic Beach Causeway). This project was initially reviewed in June 2021, since then the developer has been able to obtain all of their State and Federal Permits. The developer and engineer have also addressed the issues discussed by the TRC and submitted their revised application in March of 2022. The plan meets the parking requirements of the UDO.

Discussion and recommendation

Hursey asked for confirmation the structures are classified as townhouses, they are. Also, confirmation the service road that is being constructed parallel to the Causeway would assist with multi-use development. The boardwalk and docks planned for construction will not be public. The docks will be approved by CAMA, but the town can provide input.

Ramsey made a motion to approve MSP-21-1 Showboat Redevelopment (614/702/710 Atlantic Beach Causeway) and to recommend to Council for final approval at the April 25, 2022 meeting. Seconded by Johnson. Vote was unanimous, 6-0. Motion carried.

OTHER BUSINESS

Ramsey questioned Mayor Cooper regarding the plan for sewer on the Causeway. He stated there was not a timeline and that a public utility is working on an agreement to purchase the Sugarloaf facility. The utility would run the lines and the town's role would be to determine where the lines would run. Mayor Cooper also discussed the schedule of the proposed Boardwalk development and upcoming presentations to the jury.

There being no further action taken or business before the Board the meeting stood adjourned. The time was 7:27pm.
