CALL TO ORDER

Mayor Cooper called the meeting to order at 3:30 p.m.

APPROVAL OF AGENDA

Mayor Pro Tem Waters made a motion to approve the agenda as prepared. Seconded by Councilmember Dean. Vote was unanimous, 5-0. Motion carried.

RIGHT-OF-WAY STREET ENCROACHMENT REQUEST AT 218 OLD CAUSEWAY ROAD by William Woodard Anders, Manager/Member (Renaissance Developers, LLC, Kinston)

Mr. Anders was not present so Michelle Eitner presented the request. After tearing down the house at 218 Old Causeway Road and applying for permits, the County Health Department noted the current septic system is in the Town's right-of-way. The property owners are requesting an Encroachment Agreement from the Town.

There was discussion on other right-of-way encroachments in Town and how to address them in the future. Perhaps by narrowing the right-of-way area, but we have waterlines and other utilities in that area. No action was taken.

Councilmember Navey made a motion *to approve* the Right-of-Way Street Encroachment with 218 Old Causeway Road, LLC at 218 Old Causeway Road. Seconded by Councilmember Baker. Vote was unanimous, 5-0. Motion carried.

FY22-23 DRAFT BUDGET STATUS SUMMARY

Mr. Walker presented the \$8,825,340 Budget. We are awaiting the preliminary tax values from the County, normally we have these numbers by March. The proposed budget maintains the 20-cent tax rate with a flat and declining tax base. There was a volatile increase in employee health care cost, by 23%. The public hearing is scheduled for May 23, 2:00pm, with proposed adoption following.

COUNCIL COMMENTS

Mayor Cooper discussed inflation after Mr. Walker's budget presentation. We are looking at a 7.5-8% COLA, plus merit so some projects may be delayed by a year or so to keep employee salaries competitive.
