CALL TO ORDER

Mayor Cooper called the meeting to order at 9:30am.

CLOSED SESSION TO INTERVIEW TOWN MANAGER APPLICANTS

Councilmember Baker made a motion *to enter* Closed Session pursuant to N.C.G.S. 143-318.11(a)(6) to consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee. Seconded by Councilmember Navey. Vote was unanimous, 5-0. Motion carried.
